- Council Tax likely to rise:
 - Gvt cap on Council tax raised to 3%.
 - Adult Social Care levy being raised from 1% to 2%
 - Police & Crime Commissioner consulting on a 6.1% rise
- Gvt 5-year land supply targets: WC waiting for further guidance
